The mission of the Champlain Valley Down Syndrome Group is to provide information, resources, and support to individuals with Down syndrome and their families and to promote awareness and inclusion in our communities of people with Down syndrome to help them achieve their full potential.



Who We Are

The Champlain Valley Down Syndrome Group (CVDSG) was established in 2011 as a 501(c)(3) non-profit organization to better connect and support families within our region. Our membership currently includes over 70 families throughout Northern Vermont and the Champlain Valley of Upstate New York. Membership is free and open to anyone who wants to join.

The Board of Directors consists of four officers (President, Vice-President, Treasurer and Secretary), each serving 2-year terms. The Board meets quarterly to conduct group business, including decisions needed to support the group's activities, such as the summer barbeque and Buddy Walk in the fall, and programs such as financial support for attendance at a nearby conference. Meetings are posted on the group's website (cvdsg.org) and are open to all members. Typically, another family gathering is scheduled in the spring. The required Annual Meeting, traditionally held soon after the new year, allows the Board to report on the events and finances of the previous year.

Members of the CVDSG often provide critical outreach and facilitate networking for families, connecting groups with similar interests or concerns and often serve as the first point of contact for families who are new to the area or may have just learned about a diagnosis of Down syndrome for a newborn. The CVDSG is also an affiliate of the two primary national advocacy groups for people with Down syndrome: the National Down Syndrome Society (NDSS) and the National Down Syndrome Congress (NDSC).

Members are invited and encouraged to reach out to the Board with any ideas that could help further the Group's mission.

Programs United Dance

Founded in 2018, United Dance provides structured, professionally-led dance programs specifically designed to meet the unique needs of individuals with Down syndrome. Workshops are typically held in major metropolitan areas, such as New York and Boston, as well as cities in Europe. A special thank you to group member Julie Chauvin, whose daughter attended a session in Boston, and who was so impressed, invited the group to put on a workshop in Burlington in October, which was attended by ten participants. By all accounts, the session was a huge success and opportunities are being explored to bring the group back. Annual Meeting

10th Annual Buddy Walk

This event was one of 250 Walks across the country held in the fall to raise awareness and funds for programs that benefit people with Down syndrome and their families.

Financial Report

The CVDSG had \$5,375 in assets at the beginning of 2019. A total of \$5,423 was raised during the year through a combination of corporate and private donations, Buddy Walk registrations and t-shirt sales. A total of \$5,649 was spent during the year, primarily in support of Events, such as the Buddy Walk (including park rental, insurance, etc.) and programmatic financial support to members, as outlined above. Other funds were used to cover administrative expenses, such as membership dues to the NDSS and NDSC, as well as web site hosting, redesign and maintenance. At the end of 2019, the CVDSG had \$5,149 in assets.
